About Edgar & Ivy's Cat Sanctuary

After rescuing a six week old cat named Edgar in 2018, Edgar & Ivy's Cat Sanctuary's founders noticed he had rapid breathing and seemed to tire easily. They took him to a veterinary cardiac clinic and were given the sad news that Edgar had a terrible heart defect that should have ended his life the moment he was born. The veterinarians gave him only days to weeks to live. After caring closely for him for 8 months, Edgar succumbed to his heart defect. In that moment, they decided to start a cat rescue in Edgar's name.

Since then, Edgar and Ivy's Cat Sanctuary has provided critical care to sick kittens and cats in its medical ward. They have also opened a feral sanctuary for kittens and cats that cannot be rehomed or released after Edgar and Ivy's Cat Sanctuary's care.

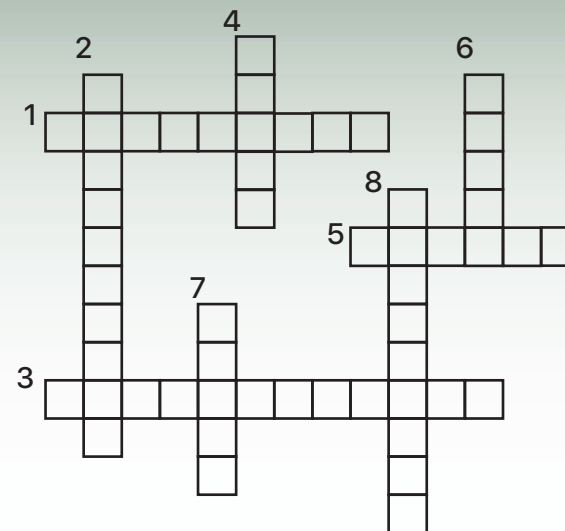
