Fourth of July Celebration Recipe

Grilled Garlic & Black Pepper Shrimp

Directions

1. Whisk chile, garlic, pepper, lime juice, and 2 tbsp. oil in a large bowl. Add shrimp and toss to coat; season with salt. Thread shrimp onto skewers.
2. Prepare grill for medium-high heat. Clean grates well, then oil. Grill shrimp, turning once, until through and lightly charred, about 5 minutes total. Serve with lime wedges dipped in chili powder.

Ingredients

1 fresh red chile, seeds removed
3 garlic cloves, finely grated
1 tablespoon coarsely ground pepper
1 tablespoon fresh lime juice
2 tablespoons vegetable oil
1 pound large shrimp, peeled & devined
Kosher salt
Lime wedges and chili powder or paprika for serving

Special Equipment

4 8-inch long metal skewers or bamboo skewers soaked in water for 30 minutes

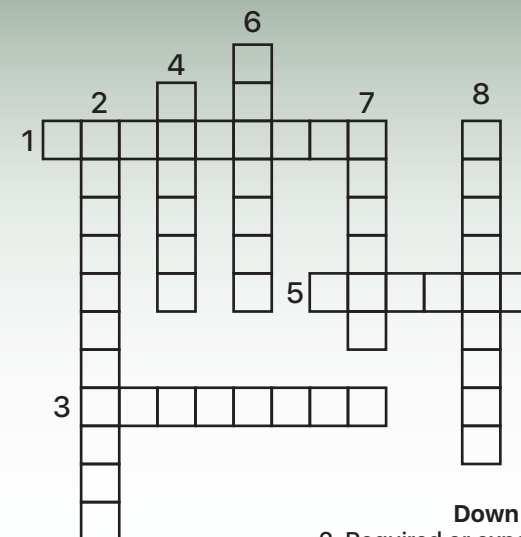
