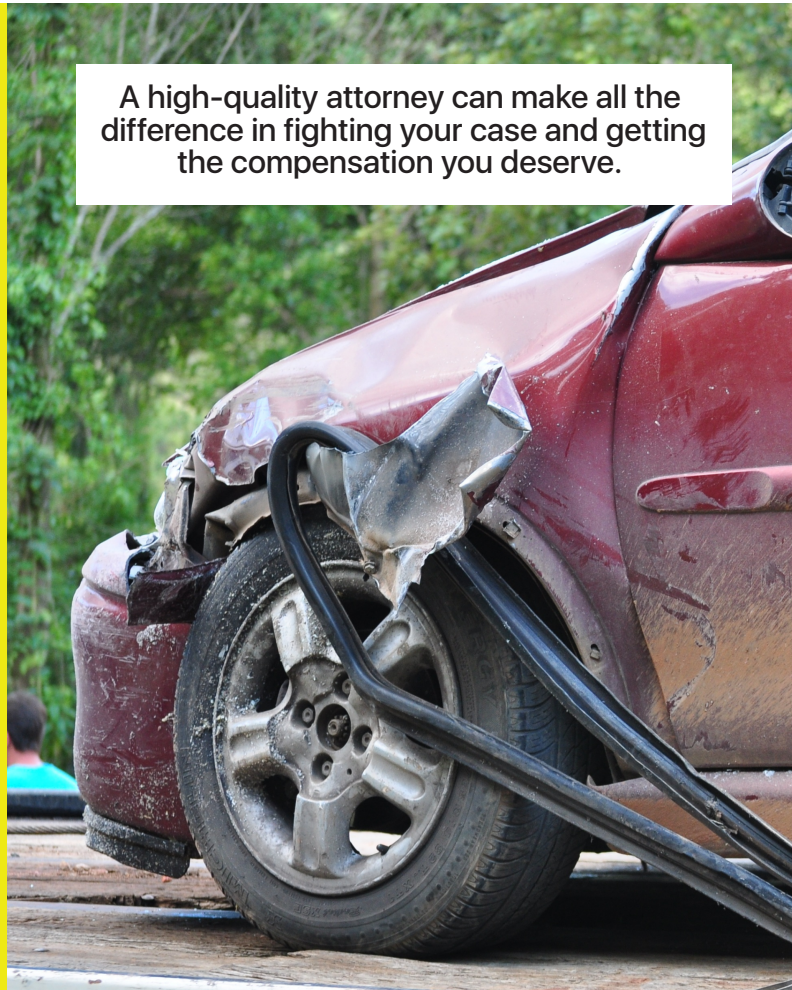

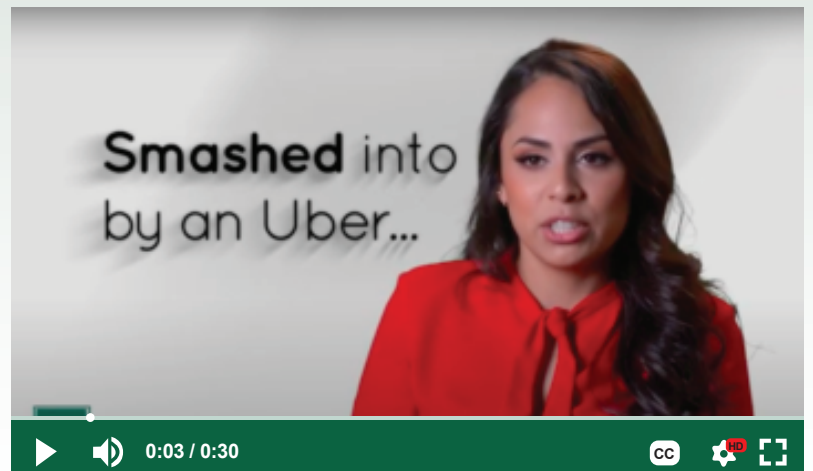

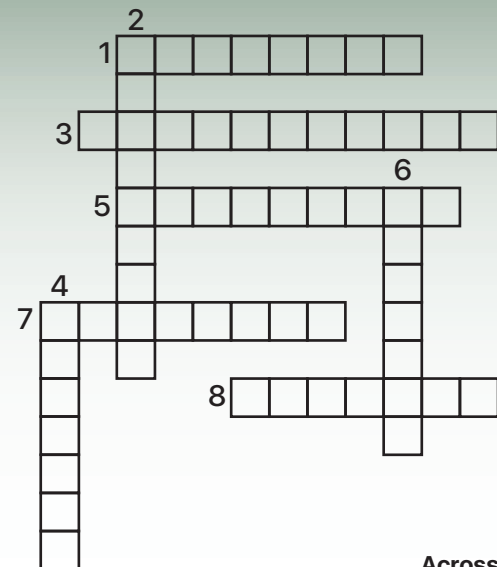

If a person suffers an injury while on the job, and a 3rd party is responsible, a personal injury firm can help an injured party bring a claim against the responsible 3rd party.

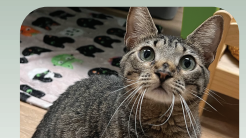
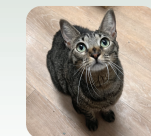
