Any updates about your injury, medical treatments, surgeries, or physical therapy can be used against you.

DO NOT POST ANY TRAVEL PHOTOS Appearing to be well enough to travel or take a vacation can be damaging to your case.



Make sure your pet is secure and comfortable in vour car


You can make them feel comfortable by bringing pet food and treats or toys that can reduce anxiety and allow them to relax while in your car.


