- Outdoor use only; never light fireworks indoors.

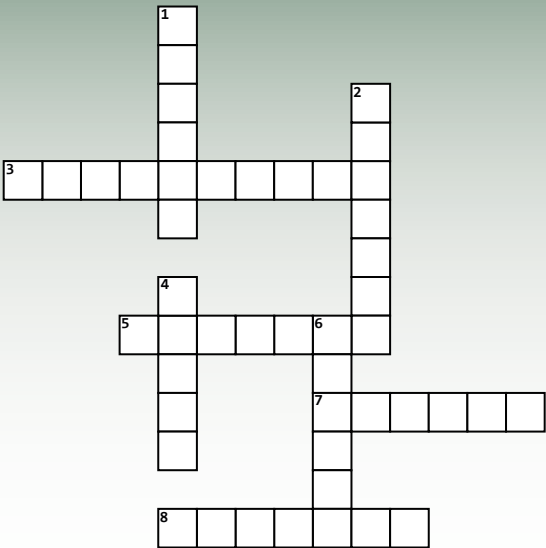
