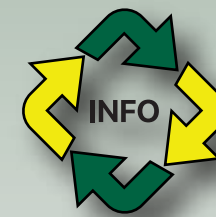
## 6 Steps After a Car Accident

After being in a car accident, most people tend to panic. It is essential to remain calm and collected to take the proper steps following a car crash. Frantically yelling at the other driver or forgetting to exchange information can seriously harm you if you decide to file a claim. Taking a deep breath will help shift your focus from the collision to what you need to do next.

Here are six simple steps you should remember after a motor vehicle accident.



First, check that you and any others involved are safe. Make sure everyone is secure and unharmed. Stay to the side of the road and away from traffic. Turn on hazard lights, if possible.



Second, exchange information with the other drivers and collect names, addresses, and phone numbers. Write the other vehicle's make, model, and license number.



Third, do not incriminate yourself by admitting fault. Many factors contribute to an accident. It is too soon to know who is at fault immediately after an accident. Do not apologize to others or try to minimize your injuries.



Fourth, file a police report. Call local law enforcement at the scene or go to the nearest police station to make a report. Try to obtain a copy or ask the officer for the report number.



Fifth, take photos of the scene. Get pictures of the vehicles involved, damage, and license plate. This documentation may help your claim later.

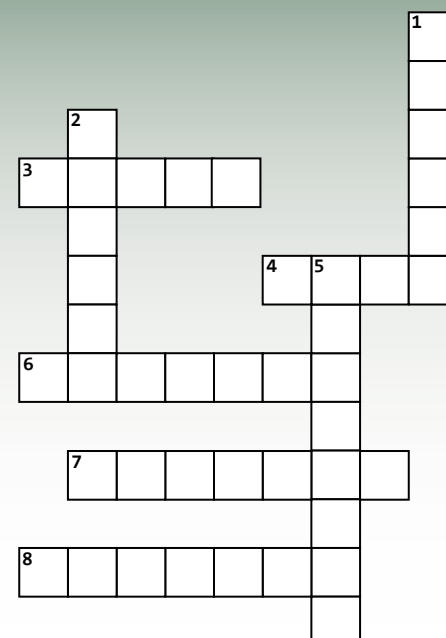
