Insurance companies and defense attorneys often monitor social media looking for posts they can use against you.

- **Avoid posting photos, videos, check-ins, or status updates** after an accident.
- Posts showing you at parties, traveling, dancing, or being active can be used to question your injuries.
- **Change all social media accounts to private immediately after the accident.**
- Provide your attorney with your social media handles and profile links.
- Ask friends and family not to tag you in photos or posts.
- **Do not discuss the accident, injuries, or settlement online.**
- Avoid accepting friend requests from people you do not know.
- **The safest option is to stay off social media while your case is ongoing.**

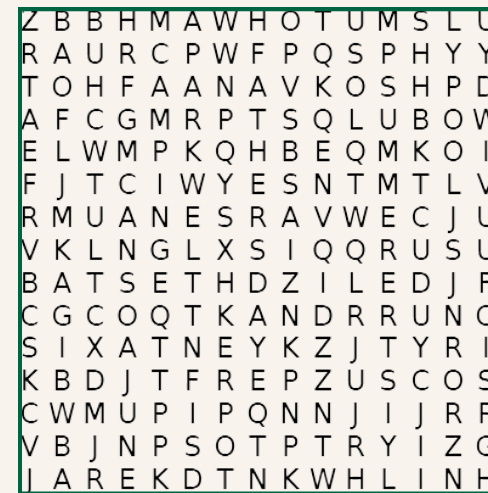

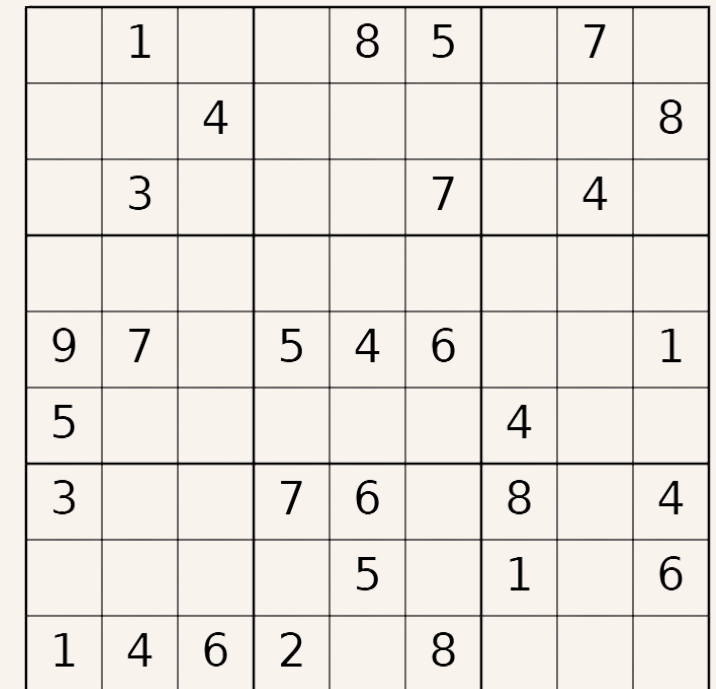
