What Should You Say to the Police After a Car Accident in Texas?

Talking to the police after an accident is generally part of the process—but **what you say matters**.

Keep these quick tips in mind:

- **Stay calm and cooperate** with officers at the scene.
- **Stick to the facts** and avoid guessing or speculating.
- **Don't admit fault** or make statements that could be interpreted as accepting blame.
- **Keep your answers brief** and only share what you know for certain.
- **Mention any injuries** and seek medical attention when needed.
- **Gather information** from witnesses and others involved, if possible.
- **Remember:** What you say at the scene could potentially affect an insurance or personal injury claim.
- **When in doubt, seek legal guidance** before providing detailed statements about the accident.

Cooperate with the police, stay factual, and avoid making assumptions or admitting fault.
